

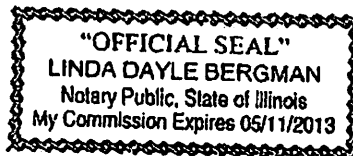
Affidavit of Document Authenticity

I, Anne Warren Smith, hear-by make the following statement of facts concerning the origination of the Attached Document Facsimiles and Transcripts.

- 1) My name is Anne Warren Smith, 127 West Moore St. Ottawa IL. 61350.
- 2) From 1981 until his death in 2007, my primary employment was as Legal Secretary to my father, Harlan Warren.
- 3) Harlan Warren was States Attorney of LaSalle County from 1952 to 1960, and was largely responsible for the arrest and subsequent prosecution of Chester Otto Weger for the Starved Rock Murders.
- 3) Upon his death, his collection of newspapers, articles, mementoes, and Documents fell into my sole possession.
- 4) In June 2007, shortly following his Death, I found within this collection a two page, hand written letter.
- 5) The Attached copies are true and accurate reproductions of the Original Document, which consisted of two sheets of pale yellow note paper approximately 6" x 4" written in blue ink.
- 6) The attached Transcript is an accurate transcription of the original Document, the only exceptions being when the original script is illegible.
- 7) Attached are Three(3)pages of Facsimiles of the Original Document, plus Three(3) pages of the type-written Transcript. Six(6) pages in total.

Upon Mr. Warren's death, the document passed into the possession of Anne Warren Smith, Mr. Warren's Daughter. The identity of the author of this Document is unknown. The Document and the transcript of the Document strongly suggests, and might outright prove, the existence of a plan to frame Mr. Chester Otto Weger for the infamous Starved Rock Murders.
